AGREED ORDER


The parties, through counsel, have represented to the Court that in order to accommodate circumstances arguably beyond the control of claimants which may have prevented those claimants from timely filing complete claims, they are jointly requesting a court approved procedure to address late filed claims. Accordingly, upon joint application of the parties, it is ORDERED:

1. All claims postmarked by April 22, 2009 and received by A-L Returns by May 30, 2009, will be processed as timely filed. All claims postmarked after April 22, 2009, shall be rejected except as specified in paragraph 2 below.
2. In addition to 1, for claimants documenting by affidavit that the Notice and Settlement Claim Form was not delivered to claimant's mailing address by April 10, 2009, any claim from any such claimant postmarked on or before June 15, 2009, and received by A-L Returns by June 30, 2009, will be processed as timely received. The affidavit may be filed with the claims package, faxed to A-L Claims at (865) 692-6020, or through class counsel.


3. Any claims received by A-L Returns after June 30, 2009, will be rejected and returned.


